OFFICIAL SWEEPSTAKES RULES

1. No purchase necessary to enter or to win. A purchase will not increase your odds of winning. All federal, state, local and municipal laws and regulations apply. Void where prohibited.
2. Eligibility. Subject to the additional restrictions below, the Alabama ONE Credit Union “Drive the ONE” Sweepstakes (the “Sweepstakes”) is open to Alabama residents (excluding all other states, Puerto Rico, Guam, and all other U.S. territories and possessions), 18 years of age or older on the date of entry, as shown on a valid driver's license or other means of identification issued by a U.S. federal or state agency, public or private school indicating the individuals residential address. Employees of Alabama ONE Credit Union and the immediate family members of, and any persons domiciled with, and such employees, are not eligible to enter or to win. The term “immediate family members” includes spouses, parents, grandparents, siblings, children and grandchildren.
3. Sponsor. The Giveaways are sponsored by Alabama ONE Credit Union at 1215 Veterans Memorial Parkway Tuscaloosa, AL 35404, unless stated otherwise.
4. How to enter. The Sweepstakes will begin at 8:00 a.m. CST on March 4, 2024 and end at 11:59 p.m. CST on June 30, 2024 (the “Sweepstakes Period”). Entries by qualified loan must consist of a qualified new vehicle or recreational vehicle loan approved \$5,000 or more closed Vehicle or Recreational Vehicle with the credit union, no later than June 30, 2024 OR No Purchase necessary completed form received by the Credit union no later than June 30, 2024.

Alabama ONE Credit Union will not be responsible for incomplete, lost, late, misdirected or illegible entries or for failure to receive entries by June 30, 2024 due to transmission failures or technical failures of any kind. All entries become property of Alabama ONE and none will be returned. Any questions regarding the number of entries submitted or the owner of an email account shall be determined by Alabama ONE in its sole discretion, and Alabama ONE reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Sweepstakes.

5. Prizes and Odds. One(1) Monthly Winner, each month for a total of four (4) months, will receive a choice of 1year of free car washes (12 month membership) with a retail value of no more than \$350 or 1year of free oil changes (1 oil change every three months for a total of 4 oil changes) with a retail value of no more than \$400. Limited to one (1) prize per participating member. Odds of winning depend on the number of eligible entries received. Substitution of prize by Credit Union is possible, but prizes are non-assignable or transferable
6. Winner Notification and Acceptance. Monthly drawings will consist of entries mentioned in section 4 by the next Friday of the following week after the last day of the month at 11:59PM CST during the promotion dates and times mentioned in section 4 OR No purchase necessary completed form. The Sweepstakes winner(s) will be notified no later than Friday of the following week, with the last prize drawing on or about July 12, 2024.

An Alabama ONE Credit Union employee will call the Prize Winner(s) and will be called up to three (3) times during regular business hours at number provided on entry form and will leave no messages. Failure to reach winner during these calls may result in disqualification of winner, forfeiture of his or her interest in all prizes, and selection of a substitute winner drawn. Winners may be required to visit the Alabama ONE Credit Union, located at 1215 Veterans Memorial Parkway Tuscaloosa, AL 35404, in person, during regular business hours or nearest Alabama ONE Credit Union to winner(s) and take a photo (photo is not necessary for winning and may be declined). Failure of any Winner to timely acknowledge Alabama ONE Credit Union's terms or conditions of these Official Rules, will result in drawing Winner's disqualification and the forfeiture of his or her interest in the prize. Winners may waive their right to receive prizes. Prizes are non-assignable and nontransferable. No substitutions allowed by winner. Prizes and individual components of prize packages are subject to availability and Alabama ONE Credit Union reserves the right to substitute prizes of equal or greater value. A 1099-MISC will be issued if required and winner(s) must provide sufficient personal information to the Credit Union for the 1099-MISC to accept the prize. Winners are solely responsible for reporting and payment of any taxes on prizes. Except where prohibited, acceptance of any prize constitutes winner's consent to the publication of his or her name, biographical information and likeness in any media for any commercial or promotional purpose, without limitation the Internet, or further compensation. Prizes not won and claimed by eligible winners in accordance with these Official Rules will not be awarded and will remain the property of Alabama ONE Credit Union.

7. Participation. By participating, entrants agree to be bound by these Official Rules and the decisions of the Sweepstakes. Alabama ONE Credit Union reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Giveaway as solely determined by Alabama ONE Credit Union. In the event the Giveaway is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of Alabama ONE Credit Union which corrupts or impairs the administration, security, fairness or proper operation of the Giveaway, Alabama ONE Credit Union reserves the right in its sole discretion to suspend, modify or terminate the

Giveaway. Should the Giveaway be terminated prior to the stated expiration date, Alabama ONE Credit Union reserves the right to award prizes based on the entries received before the termination date. By entering, each entrant (and if the entrant is under 18 years of age, the entrant's parent or legal guardian) agrees: (i) to be bound by these Official Rules, the decisions of Sponsor (which shall be final and binding in all respects) and Sponsor's Privacy Statement (ii) to release and hold harmless Sponsor, its affiliated companies from and of any and all liability for any injuries, losses or damages of any kind arising from their participation in the Sweepstakes and/or the acceptance, possession, use or misuse of the Prize; and (iii) Except where prohibited by law, acceptance of a Prize shall constitute and signify the Prize winner's (consent that Sponsor may use the winner's name, likeness, image, voice, photographs and written statements made by the Prize winner about the Sweepstakes, the Prize and about Sponsor for promotional purposes in all forms of media, in perpetuity, without payment or consideration.
